From the Director's Desk....



The first half of 2021 has been quite eventful on the campus, notwithstanding the on-going pandemic caused by the COVID 19 virus and the onset of the deadlier second wave. I am happy to report that all ISEC faculty, staff and

campus residents remained strong and healthy, and academic and co-curricular activities progressed undaunted. In this we were assisted by vaccination drives conducted on site, with the cooperation of the BBMP, which enabled all ISEC students, faculty and staff to receive both doses of the vaccine.

At the outset I am happy to inform you that our doctoral training programme, which has long been a source of pride for us, has been resumed after a hiatus of nearly three years. ISEC admitted 28 students to the PhD programme in November 2020 after a rigorous screening process, and teaching commenced in January 2021. Both faculty and students have had to learn how to function in online classrooms as the second round of the lockdown meant that campus was closed down for a period of about two months. This virtual aspect of interactions has become a reality of our times.

During this period many events were conducted, majority via online media. The Founder's day celebrations were held on January 20th in two-fold ways, on campus with residents honouring Dr VKRV Rao, our founder, and virtually with the conduct of the annual lecture. This year the lecture was delivered by Professor Kunal Sen, current Dr VKRV Rao Chair Professor, on the topic of 'Finance, Gender and Entrepreneurship: India's Formal Sector Firms.' Further, the ISEC seminar series continued apace with talks given online

by eminent scholars on topics which included Sustainable Development and lessons learned from the pandemic.

In other ISEC news, on the research front, ISEC faculty and students have been conducting multidisciplinary research in social science. The outcome of this engagement is a large number of research studies and reports on various contemporary issues, many of which relate to the COVID 19 pandemic. Thirteen research projects were completed and ten new projects were commenced by ISEC faculty. Research work has been published in the form of eleven working papers, nine in ISEC working paper series and two external. ISEC has brought out five Policy Briefs in this six-month period increasing the visibility of the excellent research work done at the institute. Three books and numerous articles in journals and edited books were published by faculty and students. At the same time, members of ISEC community have been actively participating in conferences and seminars online. Three students were awarded their doctorate degrees. Six students presented pre-submission seminars, and are well on their way to completing their doctoral training.

Last but not least, I am happy to announce that ISEC has been in discussions with the Department of Planning, Government of Karnataka, to collaborate on the way forward in the achievement of the Sustainable Development Goals (SDG) in the state. The multi-disciplinary expertise of ISEC faculty and research staff will go a long way in supporting evidence based policy making with the identification of challenges faced by the state in enabling sustainable development. ISEC researchers can provide expertise in identifying the dimensions of social development in which the state is lagging and help make policy to achieve the goals.

Orientation and Distribution of Scholarship to Social Science Talent Search Scheme Students

The Social Science Talent Search (SSTS) is an ongoing programme since January 2009, with the Orientation with Scholarship distribution programme included in 2011. The SSTS is undertaken in collaboration with Bangalore University and Christ University. While the two universities have been kind enough to sponsor scholarships to meritorious students, the programme has been receiving financial support from the Sir Ratan Tata Trust (SRTT) as part of its support to academic and scholarly initiatives at ISEC. The Programme is an initiative to inspire interest among student fraternity in social science subjects. Students at Plus Two level write a competitive exam and 25 students from Bangalore University, Jnana Bharathi Campus, Bengaluru who qualify are provided Orientations on Social Science Scope and Relevance and Scholarship. Two Orientations are conducted on Social Science Scope and Relevance in every academic year during

August and January, along with the Scholarship Distribution for selected students during their three years' tenure as undergraduate students in social science courses and a Talent Search Examination for selecting new students for those who are studying at second-year PUC level every year.

Workshop on 'Sustainable Development Goals – Vision 2030: Strategies and Action Plan for Karnataka'

The Centre for Political Institutions, Governance and Development, Institute for Social and Economic Change, in collaboration with the Karnataka Regional Branch of the Indian Institute of Public Administration Bengaluru, organized a webinar on the Government of Karnataka document, 'Sustainable Development Goals – Vision

2030: Strategies and Action Plan for Karnataka', on April 29, 2021.

Mr S Ramanathan, IAS (Retd.), Chairman, IIPA-KRB and Dr Parmod Kumar, Director-in-Charge, ISEC, in their Introductory Remarks, observed that the document being discussed is a Road Map of the Government of Karnataka for realizing the 17 Sustainable Development Goals, with a focus on equity, efficiency and sustainability. The Keynote Address was delivered by Dr. Chaya Degaokar, Additional CEO, Karnataka Evaluation Authority. She stated that the Road Map for realizing the SDGs was prepared through rigorous inputs from domain experts who served in 16 Working Committees. The strategies and action plans were developed through assessing the present status of the State in these goals and meticulous planning required for attaining the targets set for 2030. The focus is on attaining the targets in five critical goals like No Poverty, Zero Hunger, Gender Equality, Industry Innovation and Infrastructure and Clean Cities and Communities. Five discussants responded to the document, in terms of identifying missing links, grey areas, gaps and deficits, they were:

Dr A Ravindra, IAS (Retd.), former Chief Secretary, Government of Karnataka chaired and moderated the webinar. He identified several areas of concern which needed to be looked at carefully by the Government of Karnataka, to ensure that the SDGs were realized within the time frame. There is a continued neglect of the Aspirational Districts of North Karnataka. He called for an in-depth analysis of the factors responsible for the continued backwardness of the northern region over the decades, particularly Kalyana Karnataka. In fact, the poor performance of these districts seems to be bringing down the ranking of the State at the national level. He specifically referred to the lack of capacity, including the large number of vacancies in the northern districts which need to be addressed urgently. Whereas Kerala and Tamil Nadu seem to figure at the top of any index among the Southern states, why is Karnataka always lagging behind them? We seem to be high in economic growth but low in Human Development. Public Health continues to be a matter of serious concern. Dr D Jeevan Kumar, Secretary, IIPA-KRB welcomed the dignitaries, speakers and guests. Dr V Anil Kumar, Head, Centre for Political Institutions, Governance and Development, ISEC proposed a vote of thanks.

Workshop cum Focus Group Discussion on 'Household Carbon Footprint: Perceptions and Suggestions for Low Carbon Lifestyle'

The Centre for Ecological Economics and Natural Resources (ISEC, Bengaluru) collaborated with GIZ (New Delhi) to undertake a study on 'Household Carbon Footprint in India' as part of a bigger project-'Supporting the Institutionalization of Capacities on Climate Change Studies and Actions' implemented by Union Ministry of Environment Forest and Climate Change (MoEFCC), Government of India and GIZ, New Delhi. This research study aims to investigate household consumption and related environmental impacts in terms of its contribution to global climate change. In this regard, Institute for

An Overview

In the paper titled **Policy and Performance of Agricultural Exports in India (WP 509)** *Malini L Tantri* provides a detailed analysis of the trends and characteristics of agricultural exports in India and critically evaluates the trajectories of agriculture policy making in India. The excercise analysis so carried out helps to argue that undoubtedly the Agricultural Export Policy (2018) is intended to improve India's position in agricultural export. Nevertheless, in the making of the policy, many threads are left out, which need immediate attention.

Medicines constitute a significant part of out-ofpocket (OOP) medical expenditure in India. While OOP medical expenditure continues to be high for all diseases in India, cancer treatment needs special attention due to the increasing burden of cancer as compared to other diseases. This paper critically examines the drug pricing policy and drug cost containment measures in India in the light of the spending on and price variations of cancer drugs. In the paper titled The Abysmal State of Drug Cost Containment Measures in India: Evidences from Expenditure on Cancer Medicine (WP 510) Sobin George, Arun Balachandran and Anushree K N utilize the 71st and 75th rounds of NSSO Data on health expenditure to analyse the cost of medicine for in-patient and out-patient cancer care. Data on newly approved cancer drugs and drug prices were obtained from the Central Medicines Standard Control Organisation and the National Pharmaceutical Pricing Authority respectively. Results show that medicines held the highest share in the OOP cancer medical expenditure in private and public sectors and it was more pronounced in the private sector. Further, the increase in spending on cancer medicines was the highest for older persons and children below 14 years for both inpatient and out-patient care. Another significant finding of the paper is the price variation of ISEC Publications

recently approved anti-cancer medicines across brands, both under and outside price control. These findings confirm the ineffectiveness of price control measures for cancer drugs under the market-based pricing policy in India and the inadequacy of the existing cost containment measures. This calls for the rolling back of cost-based pricing of medicines and adoption of other cost containment measures which include expanding the scope of all forms, types and severities of cancer and anti-cancer medications under health insurance and adoption of a uniform treatment protocol across both private and public sectors.

India is well-known for introducing a decentralized system of reforms, and there is a considerable literature that has investigated the impact of decentralization on local development, reduction of poverty, and delivering of essential services such as health and education. However, within India, the frontier and conflict-affected erstwhile state of Jammu and Kashmir (J&K) has not received much scholarly attention in spite of having the unique distinction of introducing decentralized development reforms much prior to the introduction of such reforms at the national level or in other states. A central aim of the paper titled Peace-Building and Economic Development Through Decentralization: The Pre-Bifurcation Jammu and Kashmir Experience (WP 511) by Sardar Babur Hussain is to provide a historical background of decentralization in the erstwhile state of J&K and to assess the present working of decentralization as a peace-building strategy. The paper situates the working of decentralization within the protracted conflict situation and explores the outcomes related to local community participation and specifically on the devolution of funds and taxation powers. In the paper, the author argues that the panchayats in the region have failed to act as instruments of change and development as they have been mainly used to promote a discourse of peace and normalcy, and important aspects such as credibility and timely conduct of panchayat elections, devolution of funds, and their taxation powers have been sidelined and have been of secondary importance.

Malini L Tantri and Sanjukta Nair evaluate the trajectory of industrial policies in Karnataka and their performance at both aggregate and disaggregate levels in the paper The Policy and Performance of Industrial Sector in Karnataka **(WP 512).** While doing so, they also highlight the key challenges faced by the sector in terms of infrastructure and doing business. The analysis is based on secondary data and supplemented by insights obtained during some of the field observations.

Adequate availability and easy access infrastructures have positive implications for people's livelihood conditions. In the study entitled Infrastructure Led Livelihood: A Comparative Analysis of Hill and Valley in Manipur (WP 513) T Thangjahao Haokip and Marchang Reimeingam focus on economic infrastructures such as road transportation, communication, and electricity to draw out the impact on livelihoods in the state utilising a multi-stage sampling technique. Three districts each have been selected from the hill and the valley regions of Manipur based on the availability of infrastructure in the selected districts. Better access to road transportation in the valley region has resulted in the production of a larger quantity of agricultural products when compared to the hill region, where available roads were mostly un-surfaced. Unreliable telecommunication services in remote areas of the hill region served to isolate the people, a concern which has been unable to draw the government's attention. In the valley, usage of electricity was higher for commercial purposes due to the regularity of its supply which in turn promotes better livelihood conditions. Consequently, the average income from the livelihood activities of the hill region was lower than that of the valley. Therefore, adequate availability of infrastructure is needed for the sustainability of livelihood conditions.

The objective of the paper entitled Indian Startup Ecosystem: Analysing Investment Concentration and Performance of Government Programmes (WP 514) by Fakih Amrin Kamaluddin and Kala Seetharam Sridhar is to assess the concentration of investment in the Indian startup ecosystem and to assess the performance of the government programmes launched in order to benefit startups in the country. Descriptive statistics have been used to explain trends in investment while the *Startup India* website and RTIs were used to gather information on the performance of government programmes. The authors find that investment is concentrated in platform business model startups. The performance of government programmes

meant for startups is limited. The acceptance rate under *Startup India* is 5% to 7%. Many of the centrally-sponsored schemes listed on the *Startup India* hub do not maintain separate data on startup beneficiaries showing limited benefits to startups. The study contributes to scant academic literature available on investment trends and performance of government programmes related to Indian startups. It highlights the huge spatial and sectoral investment concentration that exists and the poor performance of government programmes.

In the study, Effects of Covid-19 Pandemic on the Rural Non-farm Self-employed in India: Does Skill Make a Difference? (WP 515), Indrajit Bairagya examines the importance of skills, especially through vocational training, for the rural non-farm sector in overcoming the disruptions caused by the Covid-19 pandemic. The differencein-differences technique has been used to assess the differential impact of the Covid-19 pandemic on the earnings of skilled and unskilled self-employed activities. Primary data has been collected from 880 Rural Non-Farm Self-employed (RNFS) individuals spread over different regions of Karnataka. Although every section of the rural non-farm activities has been adversely affected due to the pandemic, the impact is more severe on unskilled individuals as compared to skilled individuals. A difference-in-differences analysis across different income quantiles shows that imparting skill through formal vocational training is critical to every section of the RNFS. Even though skill plays an important role in promoting RNFS businesses, a large number of self-employed individuals do not show an inclination to participate in formal vocational training programmes. The author argues that policymakers need to pay attention to enhancing the provision of formal vocational training for rural non-farm self-employed individuals on a grander scale.

Buildings are responsible for at least 40 per cent of energy use in most countries, contributing to greenhouse gas emissions (World Council for Sustainable Development). IIPC estimated that by 2050, buildings are projected to emit 3,800 megatonnes of carbon. With the rapid growth in the real estate and construction sectors, it is crucial to promote green buildings. Green buildings are designed to minimize the demand for non-renewable resources and maximize the utilisation efficiency of

renewable energy sources. Against this backdrop, S Manasi, Hema Nagaraj, Channamma Kambara, N Latha, O K Remadevi and K H Vinaykumar review the initiatives taken in India towards promoting Green Buildings and constraints in diffusing the concept of green buildings in the paper **Promoting Green buildings towards achieving Sustainable Development Goals: A Review (WP 516).**

Foreign Direct Investment (FDI) is the major source of external financing to developing countries and it plays a major role in economic growth. Attracting FDI with flexible policies has therefore become a major task in emerging markets. FDI brings large capital inflows across the industries. In this study, Indian Civil Aviation Industry: Analysing the Trend and Impact of FDI Inflow (WP 517) Priyanka Saharia and Krishna Raj examine the trends and patterns of FDI inflow to the Indian civil aviation industry. The period of the study is from 2008 to 2017. Data is taken from secondary sources for all the selected variables. Selected variables of the study are FDI inflow to the air transportation industry, employment of airlines, and output of the industry. Statistical tools such as CAGR, average annual growth rate, ANOVA, Pearson's correlation coefficient and simple linear regression have been applied for analysis. The authors find that FDI alone cannot work as a game-changer for the Indian civil aviation industry. Relaxing the norms of FDI policy does not always help to bring more inflow to the industry. They argue that Indian policymakers should focus more on the financial health of the industry.
