3. General Conditions:

- i) Age to be calculated as on the last date prescribed for receipt of completed applications.
- ii) Proof of age is SSLC/Transfer Certificate.
- iii) Since this position is reserved for SC category, candidates are required to produce a copy of the valid Caste Certificate in the prescribed format issued by the Competent Authority.
- iv) The age limit may be relaxed without any limit in case of employees of the Institute (including project staff) who have worked for minimum of three years.
- v) In case of physically challenged up to 10 years; and in case of ex-Servicemen, the extent of age concession is for the 'period of military service plus three years' but not beyond 50 years of age.

4. Duration:

The appointment will be on regular basis with a two-year probation period. Depending on the evaluation of performance of the appointee after completion of two year probation, she/he will be offered a permanent position or probation extended or terminated.
