Terms and Conditions

- 1. The Annual Rate Contract (ARC) will be valid for one year from **02.11.2024** to **01.11.2025**, unless extended or terminated earlier by mutual agreement or by the Institute for Social and Economic Change (ISEC).
- 2. The prices quoted shall remain firm and fixed for the entire duration of the contract. No price variation due to market fluctuations or any other reasons will be entertained during the contract period.
- 3. All electrical materials supplied must meet the prescribed industry standards and specifications. Any substandard or defective materials will be rejected, and the supplier will be responsible for immediate replacement at no extra cost.
- 4. The supplier must deliver the materials to ISEC, Nagarbhavi, Bengaluru, within the stipulated time frame mentioned in the purchase order or as mutually agreed. Any delay in delivery may result in penalties or cancellation of the order.
- 5. Payment will be made within **30 days** after the receipt of materials and submission of the invoice, subject to verification and approval by the concerned authority at ISEC.
- 6. The supplier shall ensure that all materials are properly packaged to avoid any damage during transit. All transportation and delivery charges, including insurance, shall be borne by

the supplier.

- 7. The supplied materials will be subject to inspection upon delivery. ISEC reserves the right to reject any materials that do not conform to the required quality standards or specifications.
- 8. ISEC reserves the right to terminate the contract without prior notice in case of repeated delays, supply of substandard materials, or violation of contract terms. Upon termination, ISEC may source materials from other suppliers at the risk and cost of the defaulting supplier.
