From the Director's Desk....



Several academic events of considerable importance were held on the ISEC campus during the first half of the calendar year 2024. An important one was Prof V K R V Rao Memorial Lecture on "Determinants of Reported Taxable"

Income: Do the Wealthy Underreport their Income?", delivered by Prof Ram Singh, Director and Senior Professor, Delhi School of Economics, Delhi, on January 20, 2024. In his lecture, Prof Ram Singh argued that income tax should be proportional to the wealth owned by an individual.

This lecture was a part of the Annual Founders' Day celebrations. On the occasion, awards were presented to PhD students who secured the highest marks in the pre-PhD coursework during the academic year. A newly instituted award titled Prof R S Deshpande Award for Agricultural Economics was also presented. Three books, published by ISEC faculty, were also released on Founders' Day.

The eighteenth Professor L S Venkataramanan Memorial Lecture on "Livestock and Agri-Food System Transformation", was delivered by Prof Pratap Singh Birthal, Director, ICAR - National Institute of Agricultural Economics and Policy Research (ICAR-NIAP), New Delhi, on January 23, 2024. Prof Birthal noted that livestock transforms agri-food systems, and contributes to food security, nutrition, and livelihoods in developing countries.

Another event of importance during this period was a national conference on "Driving

Agriculture Growth: Contemporary Issues and Future Perspectives". The conference explored multifaceted challenges and opportunities in Indian agriculture. It was attended among others by Dr Ramesh Chand, Member of NITI Aayog, Prof Vijay Paul Sharma, Chairman of the Commission for Agricultural Costs & Prices (CACP) and Mr Arun Kumar, Senior Economic and Statistical Adviser at the Ministry of Agriculture & Farmers' Welfare, Government of India.

A meeting of the 'PRC Scientific and Advisory Committee (PSAC)'was held at ISEC. The purpose of the meeting was to review the research studies to be conducted by the faculty and research staff of the 18 PRCs under the Annual Work Plan 2024-25. Another significant event was the state-level training (Phase 2) for conducting National Family Health Survey – 6 in south Karnataka. This training programme aimed to provide in-depth knowledge to recruited investigators and other staff on effective and qualitative data collection from January 25, 2024 to February 21, 2024.

National Statistical Systems Training Academy (NSSTA) under the Ministry of Statistics and Programme Implementation (MOSPI), GoI, requested the Institute to organise a training programme on Applied Econometrics for the 45th Batch ISS Probationary Officers. The training programme was held for 27 probationary officers from February 19-March 1, 2024.

Given the uneven distribution of drinking water and local shortages in Bengaluru, a one-day Workshop on "Achieving Water Security in Bangalore" was organised on April 19, 2024. The workshop brought together several stakeholders for a comprehensive exchange of knowledge and perspectives on the theme of water security in Bengaluru.

ISEC

A two-day National Seminar titled 'Sustainiti: Sustainable Development in an Unequal World: Public Policy Paths' was organised from June 5-6, 2024. The seminar focused on the themes of environmental sustainability, economic sustainability and social sustainability, and 25 papers by scholars from different parts of India presented papers relating to these themes.

Social Science Talent Search Scheme (SSTSS), a flagship programme of ISEC, conducted a two-orientation programme for undergraduate students pursuing degrees in social sciences in April 2024. These programmes aimed to retain the interest of the meritorious students in social sciences and inspire them to pursue higher studies in social sciences.

Prof Kaliappa Kalirajan, Dr VKRV Rao, Chair Professor, ISEC, Bengaluru, delivered a lecture on "Gains and Hurdles for China to join the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP)" on June 10, 2024. Prof Sathish Deshpande, and Prof M N Srinivas, Chair Professor at ISEC, delivered two public lectures on January 30, 2024 and March 7, 2024. While the first lecture was on "Massification Minus Mobility: The Coming Crisis of Indian Higher Education", the second one was on "Caste After Counting: The Reshaping of Graded Inequality in the Age of Enumeration".

Regular academic activities were also undertaken on the ISEC campus. In all, 13 research projects were completed by ISEC faculty members. The themes of these research projects include soil health cards and micro-irrigation for improving agricultural productivity, skill development for non-farm employment promotion, the contribution of the informal sector to the national economy, effective online training to teachers during COVID, maternal

and child health services in PHCs, exposure to smoke among pregnant women, old age income security and the association between gram sabha participation and public goods allocation. Thirteen new research projects covering themes of onion exports, energy poverty, Kisan Credit Card, millet value chain, rejuvenation of rice fallow lands, aspirational districts, special economic zones, evaluation of finances, circular economy and NGO efforts in promoting education were initiated by the faculty members during the period.

The faculty members have also disseminated the findings of their research work. Four books were published on governance and development in Karnataka, the economic and environmental cost of traffic congestion, vachanas of devotees of Shiva and agricultural marketing. In addition, six research papers have been published in reputed journals and as chapters in edited books. During this period, 11 working papers and two policy briefs were also published.

ISEC PhD programme was also vibrant during the period. Six PhD degrees were awarded to ISEC PhD scholars. All the PhD scholars convened doctoral committee meetings to discuss the progress of their work and obtain feedback to improve the quality of their dissertations. Students have also presented their works at the biannual seminars and obtained academic inputs to improve their theses.

ISEC has been posting research output on social media for wider dissemination. In the first half of 2024, there was substantial growth in social media coverage; ISEC received over 2.2 lakh impressions for its posts and 32,610 followed ISEC social media pages across all the platforms.

National Conference on Driving Agriculture Growth: Contemporary Issues and Future Perspectives

The III National Conference of the AERC Network, on the theme 'Driving Agriculture Growth: Contemporary Issues and Future Perspectives', was inaugurated at the Institute for Social and Economic Change (ISEC) in Bengaluru from January 23-25, 2024. This event aimed to address and explore the multifaceted challenges and opportunities in Indian agriculture. Distinguished dignitaries graced the occasion, including Shri Ramesh Chand, Member of NITI Aayog, as the Chief Guest; Prof Vijay Paul Sharma, Chairman of the Commission for Agricultural Costs & Prices (CACP); Prof Pratap Singh Birthal, Director of ICAR-NIAP; and Mr Arun Kumar, Senior Economic and Statistical Adviser at the Ministry of Agriculture & Farmers' Welfare, Government of India. Their valuable insights from their respective fields significantly enhanced the conference's depth and relevance. The theme of the conference was especially pertinent, reflecting the

diverse areas and dimensions of agriculture represented by 21 projects approved by the Research Advisory Committee (RAC) of the Ministry during

2021-22. These projects included 14 all-India coordinated studies and 7 state-specific or AERC-coordinated studies, addressing contemporary challenges and future possibilities in agriculture. The sub-themes explored during the conference included Bridging the Agro-Economic Divide: Farmers' Well-being and Policy Solutions; From Ports to Plates: Tracing the Journey of Agricultural Imports and Exports of India; Plate and Pantry: Changing Consumption Patterns; Pulses Production and Trade: An Exploration of Self-Sufficiency; and Innovation in Agriculture Mechanisation: Skill Gaps and Labour-Saving Technologies.

The conference featured a mix of research paper presentations, round-table discussions, invited lectures, and a field visit, all aimed at fostering meaningful conversations and collaborations, promoting knowledge exchange, and addressing pertinent challenges in the agricultural landscape. The event underscored the importance of involving AERC/Us and invited renowned academicians and researchers in agriculture to contribute to the discussions. The chairperson emphasised the significance of the conference in advancing agroeconomic research and development, serving as

a vital platform for showcasing key results from the AERC Network, facilitating collaboration, and addressing contemporary issues in agriculture. A highlight of the conference was the eighteenth Professor LS Venkataramanan Memorial Lecture delivered by Prof Pratap Singh Birthal on "Livestock and Agri-Food System Transformation". He highlighted the critical role of livestock in transforming agri-food systems, addressing the increasing demand for animal-sourced foods, sustainable livestock production practices, and the challenges posed by climate change. The conference reaffirmed the commitment to understanding, innovating, and propelling agriculture towards sustainability, resilience, and prosperity. It brought together representatives from AERC/Us, renowned academicians, researchers, and students, creating a melting pot of ideas to shape the narrative of agricultural growth and progress. Overall, the III National Conference of the AERC Network successfully provided a comprehensive platform for discussing the contemporary challenges and future perspectives in agriculture, facilitating the exchange of ideas, fostering collaborations, and aiming to leave a lasting impact on the future of agriculture in India.

National Family Health Survey-6 State-Level Training (Phase-2) South Karnataka

Mapping and Listing Training

National Family Health Survey (NFHS-6) in South Karnataka was carried out by Population Research Centre, Institute for Social and Economic Change Bangalore. The survey was conducted under the stewardship of the Ministry of Health & Family Welfare, Government of India. The core team

(Aruna Vijaya and Devindra) attended the Training of Trainers (ToT) organised by International Institute of Population Science Mumbai at Lonavala from August 26-31, 2023. After completion of the ToT, the team conducted training for field investigators for mapping and listing activities at ISEC Bangalore from September 11-16, 2023. There were about 80 field investigators recruited and trained to carry out listing and mapping activity in 660 Primary Sampling Units (PSUs) across 15 districts of south Karnataka. The mapping and listing activities stared in September, 2023 and completed in December 2023. The districts covered were Bangalore Rural, Bangalore Urban, Mandya, Ramanagara, Mysore, Chamarajanagar, Kodagu, Dakshina Kannada, Udupi, Chikkamagaluru, Hassan, Tumakuru, Chitradurga, Chikkaballapura, and Kolar. The entire listing and mapping activity was led by Devindra, Listing and Mapping Cocoordinator, PRC, ISEC.

NFHS-6 Main Survey Training

The Training of Trainers (ToT) for the main survey was organised by International Institute of Population Science Mumbai at Varanasi from November 29 – December 17, 2023. A core team consisting of the Project Director, Prof C M Lakshmana, Demographer, Ramesha, IT Coordinator, Aruna Vijaya and Health Coordinator Dr Ramya attended the main survey ToT. In order to carry out the main survey activities, PRC recruited 42 female investigators, 28 male investigators, 28 health investigators and 3 district coordinators.

The core team conducted the main survey training during January 25, 2024 – February 21, 2024 at ISEC, Bengaluru. The training consisted of class room illustrations, mock interviews and field practice sessions for three days in rural and urban PSUs. Additionally, five invited lectures by experts were arranged in the training to help participants better understand the concepts. At the end of the training, IIPS administered a test for all the investigators to assess their knowledge and 90% of the investigators cleared the test with good marks. For the remaining 10% of the investigators a six day re-orientation sessions were organised.

Training Course in Time Series and Applied Econometrics for Indian Statistical Service – Probationers

The Centre for Economics Studies and Policy (CESP), ISEC, organised a training programme on Applied Econometrics for 45th Batch ISS Probationary Officers, Government of India sponsored by the National Statistical Systems Training Academy (*NSSTA*) under the Ministry of Statistics and Programme Implementation (MOSPI), GoI, during February 19 - March 1, 2024. As many as 27 probationary officers participated

in this training programme. During the first week of the course, participants were introduced to the basic econometric techniques and the second week concentrated on advanced time series techniques and panel data models with hands-on experience through Eviews and STATA. The special lecture on the Stochastic Production function was delivered by Prof Shanmugam, Director, Madras School of Economics. The resource persons for the course

were drawn from within the institute and experts from other institutions like Madras School of Economics, Central University of Hyderabad, IIT Hyderabad and Central University of Pondicherry.

Prof D Rajasekhar Director, ISEC, welcomed the course participants and delivered a lecture on issues in Evidence-based Policymaking. Prof Alok Kumar, Central University of Hyderabad delivered the valedictory address and distributed the certificates to the participants. Feedback on academic and administrative aspects of the course was collected

from the participants by circulating a structured feedback form designed for the training. The training was rated as Excellent by the ISS officers. The *NSSTA*, under the Ministry of Statistics and Programme Implementation (MOSPI), appreciated the effort and quality of training imparted by ISEC over the period. Currently, ISEC is the Nodal agency to impart training in applied econometrics to ISS probationary officers. The training programme was coordinated by Prof S Madheswaran and Smt B P Vani, Centre for Economic Studies and Policy, ISEC.

Workshop on Achieving Water Security in Bangalore

A One-Day Workshop on "Achieving Water Security in Bangalore" was Organised by Prof Krishna Raj and Dr Pankajkumar Sampath, Centre for Economic Studies and Policy, ISEC, Bengaluru, on April 19, 2024. The workshop, conducted over offline and online platforms, brought together national and international scholars, multidisciplinary subject experts, a diverse group of planners, government officials, academia, industries, non-governmental organisations and research scholars. The discussions were structured across three sessions, fostering a comprehensive exchange of knowledge and perspectives. More than 55 participants were involved in the discussion. Prof Krishna Raj welcomed the participants and opened the workshop by highlighting the water security challenges faced by Bengaluru. He observed that even though the situation may not be a full-blown water crisis yet, there are concerning signs of uneven water distribution and localised shortages. Prof R S Deshpande, former Director of ISEC, delivered the opening speech, emphasising the importance of integrated water management and strengthening institutions to address these challenges effectively.

The second session delved deeper into the complexities of Bengaluru's water woes. Experts raised key issues and the recommendations that emerged included: BWSSB's Master Plans forecasts for water availability have been overtaken by population growth, leading to insufficient water availability from traditional surface sources like

rivers and lakes. The alarmingly low number of wells in the city necessitates effective groundwater management strategies. Experts stressed the critical role of wastewater reuse in achieving water security. Projects like Arkavathi-V Valley for indirect potable water reuse were highlighted successful examples. Public awareness campaigns and improved drainage networks were identified as crucial aspects for promoting wider adoption. Maximizing rainwater harvesting and storage capacity, considering the limitations of traditional methods. Experts emphasised the need for water balance studies and the protection of existing streams and water bodies to create a more sustainable water management approach. Concerns regarding the sustainable expansion of Bengaluru and its dependence on other regions for water resources were raised. Balancing water needs with economic development requires careful planning and policy interventions. The suggestions included the adoption of appropriate sensors, Internet of Things (IoT) devices, and high-precision instruments for effective water management. These technologies can provide real-time data and insights for optimising water usage and distribution. The need torevise existing legal frameworks to promote water conservation and a "One Water" approach was emphasised. Additionally, streamlining data collection and sharing and strengthening institutional capacity were felt crucial for effective water governance. Experts stressed the importance of a basin-level planning approach, with the "One Water" concept considering all water sources (surface water, groundwater, rainwater, and treated wastewater) as interconnected resources.

The valedictory address was given by Dr Ramprasth Manohar V, Chairman of BWSSB. He emphasised the six dimensions of water security: Adequacy, Accessibility, Affordability, Quality, Technology and Public Participation. He also highlighted BWSSB's efforts in demand-side management, which aims to reduce water consumption through

public awareness campaigns and promote waterefficient appliances.

In conclusion, it was felt that addressing Bengaluru's water security challenges requires a collective effort from government institutions, academia, industries, and the public. Implementing the recommendations from this workshop, combined with cutting-edge technologies and fostering a culture of water conservation, can ensure a sustainable water future for Bengaluru.

Social Science Talent Search Scheme (SSTSS) Orientation Programme

The Social Science Talent Search Scheme (SSTSS) is an ongoing flagship programme of the Institute for Social and Economic Change (ISEC). The participants of the programme are meritorious students who are currently pursuing their first, second and third-year bachelor's degree in social sciences from the colleges. This programme is conducted mainly to retain the interest of meritorious students in social sciences and inspire them to pursue higher studies in social sciences. This programme also intends to build the capacity of the students.

The first and second orientation programs for the 2023-24 year took place on consecutive weekends

in April, specifically on the 20-21 and 27-28, at ISEC. Prof D Rajasekhar, Director, ISEC, inaugurated the programme and welcomed the students. A total of 15 technical sessions were held aimed at imparting knowledge on various subjects of social sciences. Subject experts from Bangalore University, ISEC and other institutions were engaged to address the students. The topics covered were FDI and its current trends in India, Indian economy, women and digital inequality in India, governance, policy and administration, public distribution system and its importance in India, relevance of NSSO data in social sciences, English communication and writing, basic statistics, emotional intelligence,

The purpose of the meeting was to review the research studies to be conducted by the faculty and research staff of the 18 PRCs under the Annual Work Plan 2024-25. The two-day meeting was attended by eight members of the advisory committee chaired by Professor T V Sekher from the International Institute for

Population Studies (IIPS), Mumbai, 32 members from the various PRCs and MoHFW officials including DG (Stats) Mr Rakesh Kumar Maurya and Director (Stats) Mr Kumar Sundaram, among others. A total of six multi-centric studies and 13 study proposals pertaining to FY 2024-25 were presented by the participants followed by a vibrant discussion of the scope and relevance of the studies. The comments and suggestions made by the advisory committee and other participants served to sharpen the focus and design of each study. The programme was coordinated by Dr Lekha Subaiya, Associate Professor and Head, PRC.

Two-day National Seminar on 'Sustainiti: Sustainable Development in an Unequal World: Public Policy Paths'



Two-day National Seminar on 'Sustainiti: Sustainable Development in an Unequal World: Public Policy Paths' was organised by CPIGD, ISEC in collaboration with DPP, MAHE and IIPA-KRB during June 5-6, 2024, at MAHE, Bangalore.

With the partial support of the SRTT a two-day National Seminar was successfully conducted during June 5-6, 2024 by the Centre for Political Institutions. Governance and Development (CPIGD), ISEC in collaboration with the Department of Public Policy (DPP), MAHE (Manipal Academy of Higher Education) Bangalore and the Indian Institute of Public Administration- Karnataka Regional Branch (IIPA-KRB), titled 'Sustainiti: Sustainable Development in an Unequal World: Public Policy Paths'. Professor V Anil Kumar from CPIGD, ISEC, Professor Jeevan Kumar from the IIPA-KRB and Dr Harini Santhanam from the DPP, MAHE coordinated the seminar along with their respective faculty members.

The seminar focused on the themes of environmental sustainability, economic sustainability and social sustainability. The main questions that the seminar papers addressed were as follows: (1) What constitutes sustainable development in a world marked by socio-economic disparities and ecological degradation? (2) Is it feasible to achieve sustainable and egalitarian economic development simultaneously? (3) What are the policy implications for enhancing healthcare, education, and access to basic amenities while fostering participatory development and gender equity? (4) How can public policies effectively address the trade-offs

between ecological sustainability and equitable development? and (5) How can inclusive growth strategies mitigate inequality while promoting sustainable development?

With the rubrics of the above questions, many sub-themes were explored during the seminar. Following the announcement of the seminar, as many as 65 abstracts were received for presentation of which 50 abstracts were shortlisted for paper presentation. After which 25 papers were presented in the two-day National Seminar. The participants were from diverse disciplines as well as regional backgrounds within India.

On June 5, 2024, the seminar began on a high note with an inaugural session in which Professor D Rajasekhar, Director, ISEC, was the chief guest speaker, Professor M V Nadkarni delivered the Keynote Address and Professor Madhu Veeraraghavan, pro-Vice Chancellor, MAHE, presented the inaugural address. Sri TM Vijay Bhaskar, IAS Retd. from IIPA-KRB Chaired the inaugural session and provided the Chairperson's remarks at the end. The inaugural was followed by a panel discussion after which the 25 participants presented their papers on June 5 and 6. On June 6, 2024, the seminar concluded on a high note again with a panel discussion and valedictory function. The Valedictory address was given by Dr A Ravindra, IAS Retd. and former Chairpersons of the Board of Governors of ISEC. The session was chaired by Sri T M Vijay Bhaskar, the current Chairperson of the IIPA-KRB.

Twentieth Professor V K R V Rao Memorial Lecture

Twentieth Prof V K R V Rao Memorial Lecture on "Determinants of Reported Taxable Income: Do the Wealthy Underreport their Income?" was delivered by Prof Ram Singh, Director and Senior



Professor Ram Singh, Director and Senior Professor, Delhi School of Economics delivered the twentieth Professor VKRV Rao Memorial Lecture on 'Determinants of Reported Taxable Income: Do the Wealthy Underreport their Income?' on January 20, 2024.

Professor, Delhi School of Economics, Delhi, as a part of Foundation Day celebrations held at ISEC on January 20, 2024.

Prof Ram Singh began his lecture with a debate on the legitimacy of income tax. He then discussed the determinates of income tax behaviour and argued that income tax should be proportional to the wealth owned by a person. However, in reality, he showed that wealthier the individual lesser is the income tax paid. He discussed the mechanisms that enable opulent groups to report partial income and the consequences of the same on the progressivity of the Indian Tax regime.

The lecture was presided over by Prof Sukhadeo Thorat, Chairperson, Board of Governors, ISEC. The welcome address was delivered by Prof D Rajasekhar, Director, ISEC, while Prof T S Syamala, Professor, PRC, ISEC, proposed a vote of thanks.

Eighteenth Professor L S Venkataramanan Memorial Lecture

The eighteenth edition of Professor L S Venkataramanan Memorial Lecture was held on January 23, 2024, concurrently during the National Conference on 'Driving Agriculture Growth: Contemporary Issues and Future Perspectives' during January 23-25, 2024. This distinguished event took place at the ISEC, continuing the tradition of honouring the legacy of Professor L S Venkataramanan, a notable figure in agricultural economics. The lecture, entitled 'Livestock and Agri-Food System Transformation', was delivered by Prof Pratap Singh Birthal, Director, ICAR -National Institute of Agricultural Economics and Policy Research (ICAR-NIAP), New Delhi. Prof. Birthal is renowned for his extensive research and contributions to the field of agricultural economics, particularly in areas of livestock and food systems.

In his lecture, Prof Birthal highlighted the critical role of livestock in transforming agri-food systems. He underscored how livestock contributes significantly to food security, nutrition, and

livelihoods, particularly in developing countries like India. Prof Birthal discussed the evolving dynamics of the livestock sector, addressing issues such as the increasing demand for animal-sourced foods, the need for sustainable livestock production practices, and the challenges posed by climate change and resource constraints. He emphasised

the importance of integrating livestock with crop production systems to enhance overall agricultural productivity and sustainability. He pointed out that such integration could lead to better resource use efficiency, improved soil health, and increased resilience to climate variability. He also discussed the potential of technological innovations, such as precision livestock farming, in driving productivity gains and environmental sustainability. The lecture covered the policy implications of transforming agrifood systems through livestock. Prof Birthal called for supportive policies that promote investments in research and development, extension services, and infrastructure to facilitate the growth of the livestock sector. He also highlighted the need for policies that ensure equitable access to resources and markets for smallholder farmers, who form the backbone of the livestock sector in India.

The National Conference on 'Driving Agriculture Growth: Contemporary Issues and Future Perspectives,' within which the lecture was held, provided a comprehensive platform for discussing various challenges and opportunities in the agricultural sector. The conference featured sessions on topics such as sustainable agriculture, technological advancements, policy frameworks, and market dynamics. It brought together researchers, policymakers, practitioners, and stakeholders from various segments of the agricultural sector to share insights and explore collaborative solutions for driving agriculture growth. The Memorial Lecture was well-received, drawing a diverse audience of academics, students, policymakers, and industry professionals. It facilitated a rich dialogue on the transformative potential of livestock in agri-food systems and underscored the ongoing relevance of Professor Venkataramanan's vision for agricultural development.

Overall, the lecture series serves as a vital platform for addressing critical issues in agriculture and economics, fostering informed discussions and promoting innovative solutions to advance the sector. The insights shared by Prof Birthal during this lecture are expected to contribute significantly to shaping future research and policy directions in the field of livestock and agricultural development.

Working Papers - An Overview

The increasing urbanisation of poverty has raised serious concerns in recent times. However, historically, governing agencies have neglected the development of identification mechanisms to locate the urban poor. Similarly, academia has misrepresented urban poverty by limiting their research scope to slum areas. The paper "Who are the Urban Poor? An Inquiry into the Identification of Urban Poor" (WP 571), by Mudassar Mahamad Jamadar, examines the mechanism to enhance the current process in the Indian setting to bridge the gap in recognising the urban poor. The Hashim Committee (2012) recommendations have been critically analysed to build a comprehensive identification mechanism. The critical review follows Pare's typology, which includes identifying debates, determining scope, aggregating evidence, and developing an existing framework. The proposed mechanism also has three stages of inquiry, namely automatic exclusion, automatic inclusion, and scoring index. The study addresses contemporary and representative conditions of urban poverty with a special focus on residential, social, and occupational vulnerability. New developments have been supported by empirical evidence to maintain methodological robustness. The study concludes that poverty has multiple dimensions and addressing all those aspects is practically unfeasible. The present study can be considered a starting point in discussing identification issues of urban poverty.

In the context of rural Karnataka, the intersection of education and social environment took centre stage with the advent of online classes in secondary schools. Sudhamani N, Anand Inbanathan and K G Gayathri Devi, in the paper "Education and Social Environment: Online Classes and Secondary School Education in Rural Karnataka" (WP 572), examine the learning process and educational situation in the schools of rural Karnataka from 2020 to 2022, shedding light on the transformative impact resulting from the transition from conventional classroom learning to virtual modes during the Covid-19 pandemic induced lockdowns. With the educational institutions remaining shut for an extended period of 18 months, it is necessary to examine students'experiences in rural areas, particularly their capacity to engage with education via online platforms. The paper examines the availability of devices among students and teachers to switch over to online learning, the teachers' knowledge level on the use of the online medium to teach students, and awareness about the guidelines regarding internet safety. The study also looked into the parents' economic and educational backgrounds, to discern their capacity to buy electronic devices, and also to monitor the students' online classes. Parents' loss of jobs during the lockdown had delayed the purchase of these devices, and they faced significant challenges for access to electricity and internet connectivity. In rural areas, the minimal exposure to online learning prior to the pandemic deepened the digital divide and disparities between urban and rural areas, as well as between affluent and underprivileged families.

The experiences of three Childcare Institutions (CCIs) functioning in the programmatic setup of the Integrated Child Protection Scheme (ICPS) in India complicates and contextualises some of the macro-social characterisations of child rights as enshrined in the United Nations Convention on Rights of Children (UNCRC). Following the anthropological approach to governance, Biplaw Kumar Singh, in the paper "Contextualising

Child Rights Governance: Genealogical Study of the Integrated Child Protection Scheme" (WP 573), captures the everyday practices and perceptions of actors and agencies running three CCIs. In doing so, it problematises the discursive binary of universal and localised ideas of child rights. Although the three CCIs examined here are rooted in the same schematic (ICPS), temporal, and spatial (Karnataka) setting, surprisingly they interpret, understand, and materialise very different conceptualisations of child rights in their daily practices. These differences not merely reflect the turbulent ways in which the universal idea of child protection is being translated, contested, and indigenised, but also exhibit the 'multiple identities of local' competing, collaborating, and strategising to construct a heterogeneous understanding of child rights governance.

In recent decades, significant changes have fundamentally altered the global trade landscape. In the paper "Navigating the Shifting Tides: A Critical Assessment of International Trade Theory and Policy in the Era of Emerging Agglomerations" **(WP 574)**, Jadhav Chakradhar and A V Manjunatha examine the comprehensive trade theories, spanning classical theories like comparative advantage to modern perspectives incorporating economies of scale, trade costs, product differentiation, imperfect competition, and new economic geography. Categorising these theories into traditional, new, and 21st-century paradigms, their theoretical and empirical developments are explored in detail. The motivations behind regional trade agreements are depicted from a trade policy perspective. The established gravity model is critically examined, considering theoretical and recent advancements. Further, the diminishing significance of distance and critiques associated with the gravity models are discussed. Finally, the concept and operations of trade agglomeration emerging in world trade are illustrated, offering a nuanced perspective on the dynamic landscape of global trade theories and their applications.

In the paper "The Poor Way to Fight Poverty: A Study of Coping Strategies Practisedbythe Urban Poor in Bengaluru, India" (WP 575), Mudassar

Mahamad Jamadar and Kala Seetharam Sridhar investigate the coping mechanisms practised by the urban poor, with special emphasis on shocks. The study is based on a primary survey of 300 poor households identified in six localities of Bengaluru in the post-pandemic period. Five themes emerged from the quantitative and qualitative content analysis: coping during (i) shocks/ crises, (ii) economic distress, (iii) social distress, (iv) health distress, and (v) education. We find various coping mechanisms practiced by the urban poor, such as skipping meals, selling assets, pulling family members to the job market, postponing expenditures, and compromising food quality. The results show that shocks triggered food insecurity among poor urban families. As part of a planned effort to fight poverty, 62% of households started savings, anticipating expenditures during emergencies (25%), & for business (29%). Friends & relatives are approached the most (85%) to tackle social distress, and 43 per cent of urban poor rely on home remedies to cut down health expenses. This study concludes that short-term coping strategies during shocks give instant relief from the crisis but make them vulnerable to falling into poverty in the long run. Safety nets should cover adversaries of shock and crises to interrupt the perpetuation of poverty among the urban poor.

Although there are several studies examining the role of human capital in economic growth, studies at the sub-national level examining this relationship are found scanty, especially from the Indian context. Filling this research gap, Surendra Kumar Naik and Indrajit Bairagya, in the paper "Does Human Capital Matter for the Economic Growth of Indian States? A Dynamic Panel Data Analysis" (WP 576), analyse the relationship using various measures of human capital for 15 major states in India from 1994 to 2018. Based on the static and dynamic panel data analysis using the Generalised Method of Moments, the critical role of Average Years of Schooling, Gross Enrollment Ratios, and financing for different educational levels in augmenting the economic growth of the Indian states is established through this study. Besides examining the relationship between economic growth and current human capital in static and dynamic panel models, the JSEC Working Papers

authorshave examined the relationship between economic growth and past human capital factors with their five-year lag values. Results reveal that the enrolment ratio of higher education influences economic growth more than other levels of education in both models. Moreover, although current public spending at the higher education level does not statistically and significantly affect economic growth, past public spending at the higher educational level has a significant impact on economic growth, perhaps because it takes a few years for individuals after completion of education to join the labour market, which makes a significant contribution to economic growth. Therefore, public spending policies should be thoughtfully devised to meet the twin objectives of egalitarian distribution of education and augmentation of economic growth.

Seven decades have passed since India gained its Independence from British colonial rule. Yet, women in the Muslim community could not reap the benefits from the earlier decades of planning or with the advent of liberalisation. In the paper "Understanding Marginalisation of Muslim Women: A Study in Bengaluru City" (WP 577), Zeenat Husain attempts to understand the factors which have led to the marginalisation of Muslim women. To have an in-depth understanding of the current situation of Muslim women in India, an analysis of literature has been done for a period before and after India gained Independence from British rule. The issues resulting in the marginalisation of Muslim women have been discussed in detail in the contemporary period. An assessment is done based on secondary and primary data showing the socio-economic conditions of Muslim women. The paper concludes by asserting the factors leading to the marginalisation of Muslim women.

The content analysis of the Integrated Child Protection Scheme (ICPS) unsettles and questions the settled normative understanding of ICPS rooted in welfare logic. Anchoring the analysis in the shared temporal landscape of ICPS and Post Washington Consensus (PWC), the paper "Integrated Child Protection Scheme and Neoliberal Governmentality: A Textual

Analysis" (WP 578), by Biplaw Kumar Singh, shows the strong linkages of ICPS' normative grid with the basic tenets of PWC. Drawing the inferences from the analytics of governmentality, this study exposes the ICPS's biases toward a market-oriented solution to child protection that invisibilises the structural constraints. Therefore, it indicates that ICPS aims to realise the rights of children through neoliberal mechanisms and strategies. In this process, the welfare goal and structure of ICPS uniquely blend with neoliberal operationalisation.

India'slargenumber of youth, who, employed, can be a dividend for the country. Initiatives such as the Skill Development and Training Programme (SDTP) were introduced to make the youth more employable. Zeenat Husain, in the paper "Making Youth Employable: Analysis of Skill Development Policy in India with Special Reference to Karnataka" (WP 579), explores with the help of secondary and primary data how far the programme has succeeded. It further examines the factors which led to the success or failure of the programme. Data analysis has been done for the state of Karnataka to understand the outcome of SDTP. Finally, concluding observations weremade and suggestions given to improve the programme.

The PESA Act of 1996 is a testament to the political dedication to empowering tribal communities and reshaping power dynamics. Its core objective is to grant tribal communities the ability to self-govern and preserve their beliefs, values, and way of life. Although the PESA Act originates from a Central Legislation, the onus of ensuring its effective implementation rests upon the states. A thorough analysis of governance within the framework of PESA reveals a spectrum of preparedness among Gram Panchayats to embrace progressive governance reforms. While some Gram Panchayats swiftly adjust to the evolving landscape, effectively wielding their newfound powers and responsibilities, others progress at a more gradual pace. Concurrently, a third category of Panchayats grapple with comprehending the extent of powers and duties delegated to them, often continuing with their established modes of operation. The focal

The mismatch between skills and learning has been an area of academic interest in India. This will be a win-win situation for the graduates and for employers as per their requirements.
