The Institute invites bids for supplying Quantitative and Qualitative Softwares

EMD: The participating bidder will have to pay Earnest Money Deposit (EMD) of Rs. 18,500/- through Demand Draft favouring The Registrar, ISEC, Bengaluru.

The Tender is based on two bid cover systems, Technical Bid and Financial Bid. The Vendors/Service Providers who qualify technically, only their Financial Bid will be opened.

The Technical Bid and Financial Bids in the prescribed format which is attached here with has to be put in two separate covers, signed and sealed must be put in one bigger Single Cover sealed and super-scribed with "**Tender for Supply of Softwares**" should reach the office of the Registrar on or before **5.00 PM, 12th March 2026**.

General Information

- a) Tenders shall be valid for 30 days from the date of opening
- b) Alternative tender will not be considered
- c) Tender document is non-transferable
- d) Conditional Tenders are liable for rejection
- e) Tenders without EMD or required documents and certificates are not attached shall be rejected
- f) ISEC reserves the right to reject any or all the tenders without assigning any reason

Terms and Conditions

- a) The bidder should be licenced dealer of the product
- b) ISEC will not deal with any entity other than the authorised bidder
- c) Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices

Evaluation of bid

- a) **Prequalification Evaluation:** The ISEC will first scrutinise the eligibility of prospective bidders as per prequalification criteria of this tender notification, based on the documents submitted by the bidder. The offers of the bidders who fulfil the mentioned prequalification criteria will be taken up for further scrutiny i.e., the technical evaluation.
- b) **Technical Bid Evaluation:**
 - i. ISEC will scrutinise the technical bids and will determine whether the technical details along with the documents furnished are as per the bid requirements and whether items are quoted as per the annexures.
 - ii. The technical evaluation will be done based on information provided by the bidder against the detailed specifications as annexures
- c) **Commercial Bid Evaluation:**
 - i. Commercial bid offers of only those bidders who qualify technically shall be opened on the date and time specified in the bid schedule. With the
 - ii. Bidder having the lowest commercial offer for the supply and installation of the material will be selected as successful bidder.

d) Supply of Goods and Services and Payment

- i. The supply of the software's must be completed within 30 days from the date of issue of purchase order.
- ii. A summary of supply and installation report must be prepared and submitted to ISEC
- iii. 100% of contract value will be released within 30 days from the date of submission of bill.

e) Penalty for Delay in Delivery:

If selected bidder fails to supply the equipment's as per the purchase order issued within 30 days of time from the date of issue of purchase order a penalty of 1% of the total cost of the bid amount per week will be deducted from the amount payable to bidder.

f) Termination of contract:

ISEC reserves the right to cancel the contract placed on the bidder if

- a) The bidder commits breach of any of the terms and conditions
- b) The bidder goes into liquidation voluntarily or otherwise
- c) The service is found unsatisfactory
